

Tender announcement

1. Health and Social Programs Agency (144 Tsereteli Avenue, Tbilisi) announces an international tender on the state procurement of medical services in the frameworks of state medical program of children healthcare of other 2010 medical services and invites all interested individuals to participate in it.

2. Object of procurement:

Lot 1 – Stationary treatment for up to 18 years-old children having rare diseases, needing permanent medical treatment and lacking parental care;

Lot 2 – Diagnostic screening on Hypothyroidism, phenylketonuria and phenylalaninemia of newborn babies and older children;

Lot 3 – Ambulatory and stationary medical treatment for up to 18 years old onco-hematologic patients.

Approximate cost of the object of procurement:

Lot 1 – 295,036.66 GEL, including 54,166.66 GEL in December 2010;

Lot 2 – 285,112.33 GEL, including – 33,333.33 GEL in December 2010;

Lot 3 – 482,573.12 GEL, including – 106,166.66 GEL in December 2010;

3. Terms of service delivery: From August 16, 2010 till December 31, 2010.

4. Taking out of tender documentation in Georgian by interested individuals will be possible up till 18:00 pm. 5. Interested candidates should submit the qualification data and tender proposal drawn up in Georgian in 3 duplicates, not later than from 10:00 am. till 13:00 pm. Tender proposals submitted behind indicated time, will not be considered and returned to the candidate unsealed.

6. Qualification data must include the following information:

6.1 For legal entities:

a) Candidate's details: address, telephone and fax, ID code, banking details);

b) An abstract from entrepreneur's register (from the Revenues Service of Ministry of Finance of Georgia);

c) A certificate from a Tbilisi or Kutaisi court (respectively) asserting that no

case of insolvency is under progress (according to registered address).

6.2 For individuals:

- a) A copy of ID asserting document;
- b) A certificate asserting him as a registered taxpayer (from the Revenues Service of Ministry of Finance of Georgia);
- c) A certificate from a court asserting that no case of insolvency is under progress (according to registered address).

6.3 As for individuals so for legal entities:

- a) An official certificate and/or license of the organization asserting that its particular activities are in accordance with current legislature;
- b) Information on candidate's material and technical capacities;
- c) Information on qualification of medical personnel and an official letter signed by the manager asserting that the medical staff are certified in accordance with the law.

7. Candidates must present the qualification data and the tender proposal in 3 duplicates (one original or notarized copy and 2 photo-copies).

8. Non-resident legal entities or individuals should present the notarized translations of the documents asserting the qualification data (indicated in the item 6) issued by the rightful bodies of their countries.

9. The candidates should present the documents asserting the qualification data of the sub-contractors, in case of their involvement.

10. References indicated in the items 6.1 and 6.2 must be issued only after the publishing of the present tender holding announcement.

11. Candidate has the right to present primary as well as alternative tender proposal(s).

12. Tender will name only one winner on each lot.

13. The mechanism providing the fulfillment of a tender proposal (guarantee, on 1 % of the tender proposal price) and of a contract (banking guarantee, on 2 % of the total price of the contract) will be utilized in the tender.
